In addition, I assume full responsibility for damages to my assigned site and agree to leave the site and the immediate area around my site in a clean and orderly manner and condition. Furthermore, vendor certifies that their outside exhibit is weighted and tied down, strong enough to withstand winds and crowds.

Each exhibitor is responsible to collect and pay their own State Sales Tax on their sales.

Vendor parking in vendor-designated parking area ONLY.

There are no alternative rain/wind dates. For a refund, written Notice of Cancellation must be received at least thirty (30) days prior to the event. No refunds will be made after that time.

GCUMC will reserve the right to request any exhibitor to remove any objectionable material (living creatures, occult, nudity, any type of weaponry, fireworks, or drug-related items). GCUMC RESERVES THE RIGHT TO DISQUALIFY ANY EXHIBITOR CAUSING ANY PROBLEMS TO FELLOW EXHIBITORS OR GCUMC. Failure to comply with our rules and regulations may result in expulsion from this event and any future event. **GCUMC reserves the right to make final interpretation of all rules.**

GCUMC will provide overnight security Thursday and Friday. The church will be locked overnight.

PLEASE DO NOT TAKE DOWN EARLY ON SATURDAY! IT'S NOT FAIR TO THE PUBLIC OR OTHER VENDORS!

ATTENTION FOOD VENDORS:

- Snack Foods Only – lunch available from the church kitchen; beverages available from the church youth group.
- Attach a copy of your State of Florida food license with your application.
- Provide your own generator. Make note on application that you will be using a generator.
- You are responsible for leaving your assigned site and the immediate area around your site in clean condition.
- Unlike many other shows, we do not charge you extra because you are a food vendor. We made this choice based on the fact that we only allow snack food items.
- We will not police your food items. We will not promise any single food vendor that he/she will be the only vendor selling any specific food item. We have multiple jewelry vendors, fabric-arts vendors, etc. If you feel you need to be the sole provider of a certain single food item, this is probably not the show for you!

ATTENTION VENDORS (This applies to All Vendors, and in particular, JEWELRY VENDORS):

- As stated on the front of this application, **ONLY HANDCRAFTED ITEMS!** We expect honesty from you on your application and in your display booth at the show.
- Do not apply indicating handcrafted items, then arrive at the show with resale items. It is very uncomfortable for all concerned if we have to ask you to leave or deny your application the following year.
- A *token* display of a few handcrafted items amongst the resale items is not sufficient to call the items you are offering for sale "handcrafted."
